STUDENT'S RIGHT TO CANCEL

If LACM receives your notice of cancellation by the end of the first week of class sessions, or the seventh day after enrollment (whichever is later), you have the right to a full refund of all refundable paid fees and are not subject to any penalties or obligations. If the school ceases operations before you graduate, you may be entitled to a refund.
